#### FINANCIAL SUPPORT REMINDERS

U.S. Immigration requires full documentation of all financial resources sufficient for the first academic year of study at a minimum. An I-20 cannot be issued if funds are inadequate or not properly documented. Due to the nature of both employment and financial aid eligibility for international students, it is strongly recommended that students come prepared to fund not only their first academic year but also their full program of study.

- Each of your financial sponsors (parent, spouse, church, etc.) must individually complete a "Section II: Affidavit of Financial Support" showing their support of you.
- Each "Section II: Affidavit of Financial Support" submitted should be either notarized or bear an additional official stamp, mark, or signature of authenticity be a party authorized to administer oaths or acknowledgements.
- Each "Section II: Affidavit of Financial Support" submitted should have a coordinating current official bank or financial statement must be attached and accompanied by a translated or converted version of it into both the English language and to U.S. currency, having been executed by either the financial institution (preferred) or applicant.
- If using scholarships as some or all of your financial support, you must submit copies of your award letter, which needs to include your scholarship amount and information regarding the disbursement process of said scholarship.
