FINANCIAL SUPPORT REMINDERS

재정 지원에 관한 안내

U.S. Immigration requires full documentation of all financial resources sufficient for the first academic year of study at a minimum. An I-20 cannot be issued if funds are inadequate or not properly documented. Due to the nature of both employment and financial aid eligibility for international students, it is strongly recommended that students come prepared to fund not only their first academic year but also their full program of study.
